

END-USER LICENSE AGREEMENT FOR C4Depot/Marketing Arts Group

C4Depot City Rig and/or other software products

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: C4Depot/Marketing Arts Group End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and C4Depot/Marketing Arts Group for the C4Depot/Marketing Arts Group software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and C4Depot/Marketing Arts Group, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. 1. GRANT OF LICENSE.
